

Traffic Calming Petition And General Guidelines

- 1. Costs – Note that costs may be the responsibility of the residents or organization requesting placement along any and all streets where there is not found a general benefit for all residents of the City of Locust Grove.**
2. Fill Out Petition – The subscribing witness of the proposed area requesting traffic calming shall fill out the first page of the petition.
3. Get others in the prescribed neighborhood to sign the petition either “Yes” or “No”. We will need to reach 100% of those in the area proposed for traffic calming.
4. Turn in completed application to the City Manager for processing. This will involve input from the Police Chief, the Public Works Director, and verification of ownership by Community Development.
5. City will inform you of a scheduled meeting with City Council for approval of the petition and any conditions for the approval, including any budgetary considerations, if necessary.
6. If city is NOT the responsible party for payment, then payment must be received before scheduled work may begin, including the order of any parts and material.
7. Completion of installation of the traffic calming device.
